

Hon. Ikenga Imo Ugochinyere Ikeagwuonu, popularly known as Ojeozi Ideato, was born in 1982 in Akokwa, Ideato North Local Government Area of Imo State, Nigeria. His education include:

#### **Political Profile and Leadership Journey**

Hon. Ikenga Ugochinyere has a rich background in leadership and public service, especially in youth advocacy, public interest activism and governance. Over the years, he has held several strategic roles, including:

- Executive Assistant to the Governor of Imo State (His Excellency, Gov. Ikedi Ohakim).
- President, National Youth Council of Nigeria (NYCN) – the first Igbo man to hold this office.
- Senate President, National Association of Nigerian Students (NANS)
- Secretary General, African Youth Council (AYC)
- Founding Member, International Youth Council, New York, USA
- Senior Special Assistant to the Senate President of Nigeria (Sen. Bukola Saraki, CON)
- Member, Inauguration/Transition Committee for Former Governor Emeka Ihedioha
- National Spokesperson, Coalition of United Political Parties (CUPP)

In 2023, he was elected to the House of Representatives, where he represents Ideato North and South Federal Constituency of Imo State. He is currently the House Committee Chairman on Petroleum Resources (Downstream) and has championed legislative reforms in the petroleum sector and pushed for constitutional amendments to support Nigeria's political and economic restructuring.

## Recognitions, Achievements and Advocacy

Hon. Ikenga Ugochinyere is widely respected for his advocacy on human rights, rule of law, and democratic accountability. His activism has contributed significantly to electoral reforms and democratic development in Nigeria. Despite facing persecution and detention for his outspokenness, he remains a fearless voice against oppression and injustice.

He is also deeply involved in philanthropy and community empowerment, especially in education, youth employment, and rural development. His scholarship and welfare schemes have supported many indigent students,

farmers, and women, while he has also facilitated job placements for youths in both the public and private sectors.

As a legal expert and strategist, he previously led lkenga Imo Ugochinyere Chambers, a high-profile legal consultancy firm in Abuja with clientele spanning the oil and gas, finance, and government sectors.

A devout Catholic, Hon. Ikenga Ugochinyere is married with children. He balances his responsibilities as a lawmaker and activist with a deep commitment to his family and the well-being of his community. His life continues to exemplify courage, leadership, and public service.

## Hon. Ugochinyere's legislative footprints in two years

In his two years of stewardship in the 10th House of Representatives (June 2023 - June 2025), Hon. Ugochinyere has recorded enviable footprints as a first-time Member of Parliament. He has sponsored 43 bills, moved 10 motions and presented 12 petitions on behalf of his constituents.

In the period under review, Hon. Ugochinyere has shaped legislative priorities, exercised oversight, advocated for public welfare, and enhanced the responsiveness and effectiveness of governance through motions raised on the floor of the House of Representatives.

## Hon. Ugochinyere: In Words and Actions

- I make it a priority to follow through on resolutions arising from motions I sponsored, especially as they relate to my federal constituency. Recognising that the passage of a motion is only the initial step, I actively monitor the progress of these resolutions with the relevant Ministries, Departments, and Agencies (MDAs)to ensure the full implementation of the said resolutions.

- Among several motions I have sponsored, I am pleased with the implementation of the resolution on the 'need to rehabilitate the collapsed Akokwa-Umuchima-Mgbe-Orlu federal road and Mgbe-Umuezeala-Oboko bridge in Ideato South Local Government Area of Imo State HR. 107/07/2023' moved on the floor of the House on Wednesday, 19th July, 2023. Steps were taken to include it in the 2023 Supplementary Budget and the 2024 Appropriation Act

## **Highlights of some of the bills**

Title: Constitution of the Federal Republic of Nigeria 1999 (Alteration) Bill, 2023 (HB.202)

**Date Presented:** March 27, 2025 **Progression:** Second reading

The bill seeks to review the requirements that qualify a person to be elected president and vice president, governor and deputy governor:

• Section 131(d) and 177(d) are amended to read as follows: A person shall be qualified for election to the office of president and governor if he has been educated up to at least University level and has earned a bachelor's degree in his chosen field of study

**Title:** Joint Admissions and Matriculations Board Act (Amendment) Bill, 2023 (HB.198)

**Date presented:** July 20, 2023 Progression: First reading

• The bill seeks to amend the JAMB Act to make UTME results valid for two years.

**Title:** A bill for an Act to establish the Alvan Ikoku Federal University of Education, Owerri, Imo State, for the promotion and development of teacher's education, make comprehensive provision for management and administration of the University and for related matters (HB.2233)

Sponsors: Speaker of the House Rt. Hon. Tajudeen Abbas, and Hon. Ikenga Ugochinyere

**Progression:** Passed by the House

This bill seeks to provide the necessary legal and administrative framework to formalize the status of the university, ensuring that it functions efficiently under a clearly defined law, governance structure and academic model that meets national and international standards.

- 8. Motion on the need to call on the Federal Government of Nigeria to construct a deep sea port and Asaba,

- commercial nerve centres of Anambra and Delta States respectively, so as to foster economic growth, industrialization and revenue generation.
- 9. Need to ensure international oil companies involved in the divestment of assets in Niger Delta region of Nigeria comply with the decommission, abandonment regulations and guidelines of the Nigerian Upstream Petroleum Regulatory Commission (NUPRC) as enshrined in the Petroleum Industry Act (PIA).


